## AMSAF "20 Under 20" CONTEST RULES

The subject/idea/theme of all submitted entries should explain why you or someone you nominate should be chosen to be granted a free rider course or discounted rider course through Team Arizona or any other training facility chosen at the sole discretion of Arizona Motorcycle Safety and Awareness Foundation (AMSAF) in a contest promoted by AMSAF (Sponsor).

The winner of this contest is required to follow all rules and meet all requirements, without exception, of TEAM Arizona (or any other rider training facility) and AMSAF, and the AMSAF sponsored "20 under 20" contest. The failure to follow any rule will result in the forfeiture of the right to further participate in the prize. Any failure to follow rules of Team Arizona will result in forfeiture of gift certificate or any other prize or gift with no liability of any kind to Team Arizona or AMSAF.

This is voluntary activity. It has physical components and may not be suitable for all people. Ride and participate at your own risk. Riding a motorcycle is an activity that can be inherently dangerous and involves risks that may cause serious injury or in some cases death.

By accepting the opportunity to train with TEAM Arizona or any other training facility, you voluntarily assume the risk and danger of injury or death inherent in this activity.

**30 day deadline:** You have one week (7 days) from the date you are notified of winning the contest to arrange a date for your training. Your training ride must be completed within 30 days of the date you win the contest.

#### Deadlines:

There is no current deadline but AMSAF and Team Arizona reserve the right to end the contest at any time.

### **Submission Guidelines:**

- 1. The contestant and anyone else submitting the entry is 100% responsible for all content of their submission.
- 2. All submissions will become the property of Sponsor.
- 3. Any submission deemed inappropriate or unsuitable, in Sponsor's sole discretion, will be disqualified.
- 4. The submission must be the original work of the contestant.
- If, in Sponsor's sole discretion, the entry (or any portion thereof) appears to have resulted in any injury or bodily harm, it will be disqualified. Entries must be in keeping with Sponsor's image and may not be offensive, as determined by Sponsor in its sole discretion, or Entry will be disqualified from the Contest.
- 6. Only those old enough to earn a motorcycle endorsement, under the age of 20 years old, and already carrying a valid Arizona driver's license and eligible to earn a valid Arizona motorcycle endorsement are eligible to win.
